

ALL SAINTS' ALBION PARK LAND SALE ORDINANCE 1984

NO. 5 1984

AN ORDINANCE to authorise the sale of certain land situate at Princes Highway Albion Park Rail and to provide for the application of the proceeds thereof.

WHEREAS the Anglican Church Property Trust Diocese of Sydney (hereinafter called the Corporate Trustee) is registered as proprietor in fee simple of the land described in the Schedule hereto (hereinafter called the land) AND WHEREAS the land is church trust property held for the sole benefit of the Anglican Church of Australia, Diocese of Sydney at Albion Park in the Parish of Albion Park but no trusts have been declared in writing concerning the same AND WHEREAS by reason of circumstances which have arisen subsequent to the creation of the trusts upon which the land is held it is inexpedient to carry out and observe the same and it is expedient that the land be now sold and the proceeds applied as hereinafter set out NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of such said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the land is held it is inexpedient to carry out and observe the same and it is expedient that the land be sold.
2. The Corporate Trustee is hereby authorised to sell the land within three (3) years after the date of assent to this Ordinance and thereafter only with the consent of the Standing Committee by public auction or private agreement in one or more lots and for such price or prices and on and subject to such terms and conditions as, to the Corporate Trustee, may seem appropriate freed from the trusts upon which it is now held.
3. The proceeds arising from the sale after paying thereout the costs of and incidental to this Ordinance and the sale or sales and transfer or transfers pursuant thereto and all outgoings to which the land is subject shall be paid to the Churchwardens of All Saints' Albion Park and be applied by them towards the cost of erection of a church, church offices, and offstreet parking on property presently held in the name of the Anglican Church Property Trust Diocese of Sydney situate at Tongarra Road, Albion Park or wholly or partly towards one or more of such objects.  
PROVIDED that pending such application the amount held shall be invested and the income arising therefrom shall be capitalised.
4. This Ordinance may be cited as "All Saints' Albion Park Land Sale Ordinance 1984".

SCHEDULE

ALL THAT piece or parcel of land situate at Albion Park in the Parish of Terragong and County of Camden being Lot D in Miscellaneous Plan of Subdivision (R.P.) Registered No. 106052 being the whole of the land in Certificate of Title Volume 7692 Folio 18.
