
Amendment of Rules re Formation of Province.

AN ORDINANCE for accepting and adopting a certain Determination of the General Synod, Session 1921, (No. III.), intituled "Determination Amending Rule 4 of Determination I., 1881."

WHEREAS a certain Determination being Determination No. III., was made by the General Synod of the Dioceses in Australia and Tasmania on the tenth day of October, 1921, intituled, "Determination Amending Rule 4 of Determination I., 1881," a copy of which is contained in the Schedule annexed to this Ordinance. AND WHEREAS it is expedient that the said Determination shall be accepted by the Church in this Diocese. THE SYNOD OF THE DIOCESE OF SYDNEY, in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England within the State of New South Wales ordains and rules as follows:—

That the said Determination and the Rules therein contained, and each and every of them shall be, and the same are and is hereby accepted and adopted, and shall so far as the same are applicable be applied to the management and government of the Church in this Diocese in like manner as if the said Determination, and the Rules therein contained, and each and every of them had been ordained and ruled by the Synod of this Diocese.

DETERMINATION AMENDING RULE 4 OF
DETERMINATION I., 1881.

WHEREAS Resolution 43 of the Lambeth Conference of 1920 states "In the opinion of the Conference four is the minimum number of Dioceses suitable to form a Province" the following amendment is made in Rule 4 of Determination I., 1881:—

Amendment of Rules re Formation of Province.

(1) In place of the word "three" contained in Rule 4 of Determination I., 1881, shall be substituted the word "four" therefor. Provided that such substitution shall not affect or invalidate any act done under or by virtue of the said Rule, and the said word so amended.
