
*Anglican Homes for Children Disposal of Assets
Ordinance 1966*

No. 27, 1966.

AN ORDINANCE to declare as Church Trust Property the real and personal estate held by the Association known as Anglican Homes for Children and "Milleewa" Church of England Home for Boys at Ashfield and to direct the disposition and declare the trusts of such assets and for purposes incidental thereto.

WHEREAS the Association known as Anglican Homes for Children (hereinafter called the Association) has for many years been carried on controlled and managed by a committee and its property and assets held by trustees pursuant to the provisions of its Constitution AND WHEREAS the said Association has also for many years controlled and conducted the home known as "Milleewa" Church of England Home for Boys at Ashfield AND WHEREAS the Association and home have now ceased to function AND WHEREAS the said Constitution declares that upon the happening inter alia of such an event the assets of the Association then remaining in the hands of the Trustees shall be disposed of in such manner as the Synod of the Diocese of Sydney or the Standing Committee of such Synod might by Ordinance determine provided that such assets should be applied as nearly as possible to the use and benefit of any home homes or hostels for children in connection with the Church of England in Australia in the Diocese of Sydney AND WHEREAS it is expedient that the said assets particulars whereof are in the main as set out in the Schedule hereto be now declared Church Trust Property and disposed of as hereinafter set out NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of such Synod HEREBY DECLARES RULES AND DIRECTS as follows:-

1. All the property real and personal of the Association including any belonging to or in the name of "Milleewa" Church of England Home for Boys and without limiting the generality of such property including that set out in the Schedule hereto together with all estate right title and interest whether vested contingent or expectant under any will deed trust or other instrument in favour of the said Association or "Milleewa" Church of England Home for Boys shall as from the passing of this Ordinance become and be Church Trust Property within the meaning of the Church of England Trust Property Act 1917 and shall henceforth be held upon trust for the use and benefit of the Home Mission Society Diocese of Sydney as constituted by the Home Mission Society Ordinance 1911 to be applied by that Body for the Charlton Memorial Homes.

2. The Treasurer of the said Society or other person duly authorised is hereby empowered and authorised to give an effectual receipt and discharge for any moneys and any legacies and bequests to which the said Association and "Milleewa" Church of England Home for Boys may under any will deed trust or instrument be now or contingently entitled or may at any time in the future become so entitled.

3. The said Association shall as from the passing of this Ordinance be and become responsible for any debts and liabilities of the said Association.

4. This Ordinance may be cited as "Anglican Homes for Children Disposal of Assets Ordinance 1966."
