

CAMPBELLTOWN VARIATION OF TRUSTS ORDINANCE 1985

NO. 42, 1985

AN ORDINANCE to vary the trusts of certain land at Campbelltown in the City of Campbelltown Parish of St. Peter and County of Cumberland.

WHEREAS

A. Anglican Church Property Trust Diocese of Sydney (hereinafter called the "Corporate Trustee") is the registered proprietor of the whole of the land comprised in Certificate of Title Volume 12735 Folio 210 more particularly described in the Schedule hereto. 5

B. The land described in the Schedule hereto is held upon trust partly for the appropriation thereof as a site of a dwelling house, garden and other appurtenances for the Clergyman duly appointed to officiate in the Church of the United Church of England and Ireland as by law established erected at Campbelltown and known as St. Peter's partly for the erection thereon of a school house in connection with the United Church of England and Ireland as by law established and partly for the interment of the dead according to the use of the United Church of England and Ireland as by law established and partly for the erection thereon of a church of the United Church of England and Ireland as by law established. 10 15

C. By reason of circumstances which have arisen subsequent to the creation of the trusts it is inexpedient to carry out and observe the same to the extent that they are hereby varied. 20
NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

1. By reason of the circumstances which have arisen subsequent to the creation of the trusts upon which the land described in the Schedule hereto is held, it is inexpedient to carry out and observe the same and it is expedient that such trusts be varied as hereinafter set out. 25

2. The land described in the Schedule hereto shall henceforth be held upon trust for a :- 30

- (a) church;
- (b) residence for a minister, assistant to the minister, or person employed by the churchwardens;
- (c) halls or halls;
- (d) school or other place of assembly;
- (e) burial ground;


or partly for one or another or others of those purposes in connection with the Anglican Church of Australia within the Diocese of Sydney for the sole benefit of the Parish of Campbelltown or any parish or ecclesiastical district into which it may subsequently be formed or form a part.

3. This Ordinance may be cited as the "Campbelltown Variation of Trusts Ordinance 1985".

THE SCHEDULE

ALL THAT piece or parcel of land at Campbelltown in the City of Campbelltown Parish of St. Peter and County of Cumberland being Lot 4 in Deposited Plan 575491 and the land in Certificate of Title Volume 12735 Folio 210.
