## Choice of Superannuation Fund

---

All ordained clergy have their superannuation contributions paid to the AMP SignatureSuper Fund (to Anglican National Super Fund) or an 'Alternate Fund' of their choice through the Parish Cost Recovery (PCR) system.

**If you wish to exercise the choice of an alternate fund**, the following requirements apply:

1. The Alternate Fund nominated **must** be a complying superannuation fund. This can be evidenced by a letter from the trustee stating that the Alternate Fund is a complying fund, and (for a self managed superannuation fund) a copy of documentation from the Australian Tax Office confirming that the Alternate Fund is regulated.
2. The 'Choice Notice' **must** be in writing, providing all of the details on the attached form '*Notice of Choice of Superannuation Fund under clause 12A*' **and** include the attachments specified.
3. The 'Choice Notice' **must** include either the Fund ABN or the Fund SPIN. Payment to your Fund of choice cannot be made if we do not have either of these numbers.
4. It is the member's responsibility to notify the Fund of their Tax File Number.
5. Only one Choice Notice may be given in each 12 month period **and** only one Alternate Fund can be specified in a Choice Notice.

From the month following the receipt of your completed Choice Notice and attachments, we will apply all future PCR superannuation contributions to your Alternate Fund.
