*The Christ Church St. Lawrence Sydney Resumptions Ordinance  
1929, Amending Ordinance 1940.*

No. 12. 1940.

AN ORDINANCE to amend The Christ Church St. Lawrence  
Sydney Resumptions Ordinance 1929 (No. 9 of  
1929).

The Standing Committee of the Synod of the Diocese of  
Sydney in the name and place of the said Synod ordains and  
declares as follows:

1. The Schedule referred to in "The Christ Church St.  
Lawrence Sydney Resumptions Ordinance 1929" is hereby re-  
pealed and in lieu thereof the following new Schedule is  
substituted:

THE SCHEDULE HERINBEFORE REFERRED TO.

ALL that piece of land commencing at the north-western  
corner of the present building formerly occupied by  
Marcus Clark & Company situated in George Street  
Sydney extending northerly fifty two feet six inches  
thence easterly for twenty feet thence southerly for nine  
feet thence easterly again for nine feet thence southerly  
for forty three feet six inches thence westerly for twenty  
nine feet to the point of commencement.

2. The following new clause shall be added to the said Ord-  
inance immediately after Clause 7 of the said Ordinance:—

7(a) "The rents profits and income to arise in respect  
of the leasing of the lands described in the Schedule  
hereto and the buildings erected or to be erected there-  
on or any part or parts thereof under the powers hereby  
conferred shall be received by the said Church of  
England Property Trust Diocese of Sydney and after  
payment thereof of all costs charges and expenses of  
and incidental to this Ordinance and the rates taxes  
and other outgoings payable in respect of the said  
lands the balance of such rents profits and income shall

be paid by the said Church of England Property Trust Diocese of Sydney as regards five-sevenths parts thereof to the Churchwardens for the time being of Christ Church St. Lawrence Sydney to be applied by such Churchwardens as parochial church funds within the meaning of the Sydney Church Ordinance 1912 or any ordinance amending or taking the place of the same and as regards the remaining two-sevenths of such rents profits and income to the Rector for the time being of Christ Church St. Lawrence Sydney."

3. This Ordinance shall be styled and cited as "The Christ Church St. Lawrence Sydney Resumptions Ordinance 1929 Amending Ordinance 1940."
