
*Church of England National Emergency Fund Constitution
Ordinance Amendment and Variation of Trusts Ordinance
1972*

No. 22, 1972

AN ORDINANCE to amend the powers and functions of the Board of Management which manages and controls the Church of England National Emergency Fund and to vary the trusts upon which the assets of the Fund are held.

WHEREAS the Church of England National Emergency Fund in the Diocese of Sydney was formed about the year 1939 for the purpose of ministering to the needs of service men and women during the second world war AND WHEREAS by the Church of England National Emergency Fund Constitution Ordinance 1958 (hereinafter called the "Principal Ordinance") the said Fund was placed under the management and control of the Board of Management constituted thereby with the powers and functions therein set forth AND WHEREAS the assets of the said Fund consist of the property described in the Schedule hereto and are held upon trust for the purposes of the said Fund AND WHEREAS another national emergency may occur in the future AND WHEREAS it is expedient that the powers and functions of the said Board of Management be revised AND WHEREAS it is expedient that the trusts on which the assets of the said Fund are held be varied to the extent hereinafter provided NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:—

1. (1) This Ordinance may be cited as "Church of England National Emergency Fund Constitution Ordinance Amendment and Variation of Trusts Ordinance 1972".

(2) The Principal Ordinance as amended by this Ordinance may be cited as "Church of England National Emergency Fund Constitution Ordinance 1958-1972".

2. The Principal Ordinance is amended by:—

(a) substituting the following for Clause 8:—

"8. The Board shall minister to the needs of men and women during times of national emergency."

(b) inserting the following as Clause 8A:—

"8A. Subject to its responsibilities and obligations under Clause 8, the Board may support and assist in such manner as the Board may consider appropriate all or any of the activities now or at any time after this Ordinance is assented to conducted by:—

- (a) the Church of England Youth Department of the Diocese of Sydney;
- (b) any body or organisation which is supported or assisted from time to time by the Church of England Youth Department of the Diocese of Sydney;
- (c) the Board of Education of the Diocese of Sydney;
- (d) the Women's Auxiliary of the Church of England National Emergency Fund now known as the Sydney Diocesan Churchwomen's Association; and/or
- (e) the Board of Management constituted by the 'Gill-bulla' Board of Management Constitution Ordinance 1962;

and, without limiting the generality of the foregoing in any respect, may provide for or assist in the providing for the erection, maintenance, renovation or repair of any building or any part of any building and the purchase or other acquisition of any land or any estate or interest therein used or which may be used in connection with or for the purposes of any of the said activities."

- (c) by omitting Clause 10;
- (d) by substituting the words "the property described in the Schedule hereto and any other property the management or control of which may be or which may have been committed to the Board" for the words "the said properties" in the first sentence of Clause 9 of the Principal Ordinance;
- (e) by substituting the Schedule to this Ordinance for the First and Second Schedules; and
- (f) by omitting all but the first, second and last recitals.

3. (1) By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the property described in the Schedule hereto is held it is inexpedient to carry out and observe the same to the extent that the said trusts are hereby varied.

(2) The said property shall be held upon trust to permit the same to be applied for all or any of the purposes and powers of the said Board of Management set forth in the Principal Ordinance as amended by this Ordinance.

SCHEDULE

ALL moneys payable to the Board pursuant to the C.E.N.E.F. and Glebe Administration Board Variation of Trusts Ordinance 1971 and any ordinance amended by that Ordinance.

ALL THAT piece or parcel of land situate in the Municipality of Randwick Parish of Alexandria and County of Cumberland comprised in Certificate of Title Volume 8292 Folio 111 and known as 87 Darley Road, Randwick.

PLANT and equipment, furniture and fittings situated at the property known as 87 Darley Road, Randwick and at the building known as "C.E.N.E.F. Memorial Centre".

CREDIT balance with the Bank of New South Wales.

DEBTS owed by sundry debtors.

\$3,000 deposited with New South Wales Permanent Building Society and accumulated interest thereon.

\$8,000 deposited with Industrial Acceptance Corporation Limited.

HUTS and equipment at Ingleburn and Concord.
