AN ORDINANCE for accepting and adopting a certain Determination of the General Synod, Session 1926, (No. 1) intituled "Determination to further amend the Rules for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania, Determination I., General Synod, 1916 (made 13th October, 1916)."

WHEREAS a certain Determination being Determination No. 1 was made by the General Synod of the Dioceses in Australia and Tasmania on the twenty-sixth day of October 1926 intituled "Determination to further amend the Rules for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania Determination 1 General Synod 1916 (Made 13th October, 1916)" a copy of which is contained in the Schedule annexed to this Ordinance AND WHEREAS it is expedient that the said Determination shall be accepted by the Church in this Diocese. The Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England within the State of New South Wales ordains and rules as follows:—

That the said Determination and the Rules therein contained and each and every of them shall be and the same are and is hereby accepted and adopted and shall so far as the same are applicable be applied to the management and government of the Church in this Diocese in like manner as if the said Determination and the Rules therein contained and each and every of them had been ordained and ruled by the Synod of this Diocese.

DETERMINATION TO FURTHER AMEND THE RULES FOR THE CONSTITUTION OF A BOARD OF MISSIONS OF THE CHURCH OF ENGLAND IN AUSTRALIA AND TASMANIA, DETERMINATION I., GENERAL SYNOD 1926 (MADE 13th OCTOBER, 1916).

WHEREAS it is expedient to amend Determination I. General Synod 1916 (made 13th October, 1916) be it enacted by the Archbishops Bishops Clergy and Laity in General Synod assembled as follows:—

In clause one the following words "All vacancies occurring when the General Synod is not in session shall be filled by the persons to whom the power of election is herein given. Provided that the Executive Committee of the General Synod shall in this respect act on behalf of the General Synod" are hereby omitted and in lieu thereof the following words are hereby inserted, "All vacancies occurring when the General Synod is not in session shall be filled by the Board."
