*Diocesan Revenues Ordinance 1937.*

No. 14, 1937.

AN ORDINANCE to make further provision for the application of the income of the Church Trust Properties referred to in the "Sydney Diocesan Revenues Act of 1905."

WHEREAS the Church Trust Properties referred to in the "Sydney Diocesan Revenues Act of 1905" and the income thereof is now subject to the trusts mentioned in and extended by the said Act and mentioned in the Ordinances relating to the said property. AND WHEREAS since the creation of the said trusts and the extension of the same as aforesaid the said income has become and is now more than sufficient to reasonably satisfy all the purposes to which the same is applicable and a surplus of £400 has accumulated and it is expected that from time to time hereafter a surplus amounting to £200 per annum will remain after reasonably satisfying all the said purposes. AND WHEREAS by reason of the circumstances aforesaid and of other circumstances subsequent to the creation and extension of the said trusts it has become inexpedient to carry out or observe the same in their entirety. AND WHEREAS the amount of stipend to be paid to the Bishop of Sydney is not adequate to the purposes for which the same is required to be used by the present Archbishop of Sydney in his extended and extending work for the Church in the said Diocese. AND WHEREAS in order to afford a measure of relief it is expedient that an annual grant at the rate of two hundred pounds in respect of each year as from the first day of April 1935 should be paid out of the said surplus income to the present Archbishop of Sydney during his occupancy of the See of Sydney.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:—

1. By reason of circumstances subsequent to the creation of the Trusts of the income of the property referred to in the "Sydney Diocesan Revenues Act of 1905" it has become inexpedient to carry out or observe the said trusts in their entirety.

2. The Church of England Property Trust Diocese of Sydney is hereby authorised to pay out of the said surplus income or any fund for the time being representing surplus income of the said property sums of two hundred pounds in respect of each year as from the first day of April 1935 to the present Archbishop of Sydney during his occupancy of the See of Sydney.

3. This Ordinance may be cited as the "Diocesan Revenues Ordinance 1937."
