*Diocesan Revenues—St. Philip's Glebe (Further Mortgaging)*  
*—Bishopthorpe Ordinance 1957.*

No. 56, 1957.

AN ORDINANCE to make further provision for the application of the rents issues and profits of the Bishopthorpe Estate towards the expenses incurred by the present Archbishop of Sydney and for that purpose to vary the trusts to which the Bishopthorpe Estate is now subject; to amend the Diocesan Revenues—St. Philip's Glebe (Further Mortgage) — Bishopthorpe Ordinance 1949-1952; and for other purposes connected therewith.

WHEREAS:—

1. The sum of £13,000 authorised to be raised by the Diocesan Revenues—St. Philip's Glebe (Further Mortgage)—Bishopthorpe Ordinance 1949-1952 (herein called "the principal Ordinance") has now become exhausted.
2. It is expedient as from the 17th February, 1955, to apply the net rents issues and profits of the Bishopthorpe Estate in continuing the payments provided for by the principal Ordinance and by the Diocesan Revenues — St. Philip's Glebe (Further Mortgage)—Bishopthorpe Ordinance 1952 (herein called "the amending Ordinance") and in making the further payments hereinafter authorised.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and in the place of the said Synod ordains and declares as follows:—

1. (a) This Ordinance may be cited as the "Diocesan Revenues — St. Philip's Glebe (Further Mortgaging)—Bishopthorpe Ordinance 1957."
- (b) This Ordinance shall be construed with the principal Ordinance, as amended, and with the amending Ordinance.
- (c) The principal Ordinance as further amended by this Ordinance may be cited as the "Diocesan Revenues—St. Philip's Glebe (Further Mortgage) —Bishopthorpe Ordinance 1949-1957."

2. By reason of circumstances subsequent to the creation of the trusts to which the Bishophorpe Estate is now subject it is inexpedient to observe such trusts to the extent to which the same are varied by this Ordinance.

3. Clause 4 of the principal Ordinance is amended:

- (a) By omitting the word "and" at the end of sub-clause (a); and
- (b) By inserting after sub-clause (a) the following further sub-clauses:—

"(aa) in payment of the sum of One thousand two hundred pounds (£1,200) per annum by monthly instalments to the present Archbishop of Sydney to be applied by him in accordance with sub-clause (a) of Clause 3 of this Ordinance;

"(ab) as and when in the opinion of the said Standing Committee it becomes necessary from time to time in the purchase exchange or acquisition of a suitable motor car or motor cars for the use of the present Archbishop of Sydney or any person administering the Diocese;

"(ac) in payment of a sum or sums not exceeding in the aggregate six hundred pounds (£600) per annum for one or more of the purposes set out in Clause 3 of the Archbishop of Sydney Stipend Ordinance 1909 Amending Ordinance 1945 during the occupancy of the See of Sydney by the present Archbishop;

"(ad) on and from April 1st, 1957, in the further payment of a sum or sums not exceeding in the aggregate eight hundred pounds (£800) per annum in accordance with the last preceding sub-paragraph; and"

4. Clause 3 of this Ordinance shall be deemed to have taken effect on the 17th February, 1955, and the application of the net rents issues and profits of the Bishophorpe Estate in accordance therewith is hereby confirmed.
