AN ORDINANCE to accept and to apply the provisions of Determination III of 1950 intituled "A Determination to amend the Determination for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania General Synod, October 1916 (Amended 1921, 1926 and 1945)" in the order and good government of the Church of England within the Diocese of Sydney.

WHEREAS Determination No. III 1950 intituled "A Determination to amend the Determination for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania General Synod, October, 1916 (Amended 1921, 1926 and 1945)" a copy whereof is contained in the Schedule hereto has been made by General Synod.

AND WHEREAS under Article No. 3 in the Schedule to the Church of England Constitutions Act Amendment Act of 1902 the Diocese may make Ordinances upon and in respect of all matters and things concerning the order and good Government of the Church of England and the regulation of its affairs within the Diocese.

AND WHEREAS by an Ordinance assented to on 21st June, 1875, regulating the method of accepting Determinations of General Synod it was provided that the mode of acceptance of such Determinations should be by Ordinance.

AND WHEREAS it is expedient to accept and to apply the provisions of the said Determination No. III 1950 as hereinafter expressed.

The Synod of the Diocese of Sydney in pursuance of its powers under the said Act hereby ordains and rules as follows:

The said Determination No. III 1950 is and the provisions therein contained are accepted and shall be applied in the order and good government of the Church of England within this Diocese in like manner as if the same were herein and hereby expressly ordained and ruled.

GENERAL SYNOD OF THE DIOCESES IN AUSTRALIA

DETERMINATION III, SESSION 1950.

(Made 28th November, 1950.)

A DETERMINATION to amend the Determination for the Constitution of a Board of Missions of the Church of England in Australia and Tasmania General Synod, October 1916 (Amended 1921, 1926 and 1945).

WHEREAS Rule 5 provides for not less than three ordinary meetings of the Board to be held each year, it has been thought desirable to alter this Rule to provide for not less than two meetings.

Be it enacted by the Bishops, Clergy and Laity of this Synod:—

Rule 5 shall be amended by omitting the word "Three" before the words "ordinary meetings of the Board" and by inserting the word "two" in place thereof.
