*The Glebe Administration Amendment Ordinance 1935.*

No. 10, 1935.

AN ORDINANCE to amend and supplement the "Glebe Administration Ordinance 1930" (No. 15, 1930).

WHEREAS by Clause 5 of the "Glebe Administration Ordinance 1930" (hereinafter referred to as the said Ordinance) it is provided that seven persons shall constitute the Board AND WHEREAS it is expedient that the Archbishop of Sydney for the time being shall be an ex officio member of such Board.

AND WHEREAS by Clause 14 of the said Ordinance provision is made for the application of the rents issues and profits of St. Philip's Glebe.

AND WHEREAS by reason of circumstances subsequent to the creation of the trusts to which the said rents issues and profits are subject it is expedient to vary such trusts in manner hereinafter mentioned and to make the further provisions hereinafter contained.

Now the Synod of the Diocese of Sydney ordains directs declares and rules as follows:—

1. By reason of circumstances subsequent to the creation of the trusts to which the said rents issues and profits of St. Philip's Glebe are subject it has become inexpedient to carry out or observe such trusts so far as the said trusts are inconsistent with the provisions of this Ordinance.

2. The said Ordinance is hereby amended by inserting in clause 14 thereof immediately after sub-clause (f) the following new sub-clause namely:—

(ff) (1) In paying to Mrs. Kirkby the widow of the late Bishop Kirkby the sum of £55/10/1 being stipend of the late Bishop Coadjutor from 12th July to 31st July 1935 and an allowance at the rate of Two hundred pounds per annum during her life as from the first day of August 1935 and also in paying the sum of One hundred and seventeen pounds seven shillings (£117/7/0) for medical hospital and funeral expenses of the late Bishop Coadjutor.

(2) Any advances heretofore made by any person or persons or out of any fund or funds and applied

wholly or in part to any of the purposes aforesaid shall be repaid or readjusted in account in such manner that the payments authorised by the first part of this sub-clause shall be borne by the said rents issues and profits of St. Philip's Glebe.

3. The said Ordinance is further amended as follows:—

In Clause 5 immediately after the words "consist of" insert the words "The Archbishop of Sydney for the time being ex officio and"

Immediately after the word "seven" insert the word "other".

Immediately after the word "Synod" insert the word "Elected"

4. This Ordinance may be cited as "The Glebe Administration Amendment Ordinance 1935."
