
*Glebe Administration Further Amendment
Ordinance 1939.*

No. 19, 1939.

AN ORDINANCE to further amend and supplement the "Glebe Administration Ordinance 1930" (No. 15 of 1930) and to amend and supplement the "Glebe Administration Further Amendment Ordinance 1937."

WHEREAS by the "Glebe Administration Further Amendment Ordinance 1937" the "Glebe Administration Ordinance 1930" (hereinafter referred to as the Principal Ordinance) was amended and the firstmentioned Ordinance ceases to function after the thirty-first day of March 1940 except in certain particulars.

AND WHEREAS by reason of circumstances subsequent to the creation of the trusts to which the rents issues and profits of St. Philip's Glebe are subject it is expedient to vary such trusts in manner hereinafter mentioned and to make further provisions as hereinafter contained.

AND WHEREAS it is expedient to extend the provisions of the "Glebe Administration Further Amendment Ordinance 1937" for a further period in the manner hereinafter contained.

AND WHEREAS it is expedient that a separate assessment be made for the purpose of assisting to provide adequate allowances to widows and children of the clergy of the Diocese of Sydney.

Now the Synod of the Diocese of Sydney ordains directs declares and rules as follows:—

1. By reason of circumstances subsequent to the creation of the trusts to which the said rents issues and profits of St. Philip's Glebe are subject it has become inexpedient to carry out or observe such trusts insofar as the same are hereby varied.

2. After the thirty-first day of March 1940 being the date upon which the "Glebe Administration Further Amendment Ordinance 1937" ceases to have effect the said Ordinance shall except as hereinafter provided continue in full force and effect until the thirty-first day of March 1943.

3. An Assessment in accordance with the particulars as set out in the Schedule to the "Glebe Administration Further Amendment Ordinance 1937" shall take effect as from the first day of

April 1940 to the thirty-first day of March 1941 and an annual assessment shall take effect from the first day of April 1941 to the thirty-first day of March 1943 based on the assessment to be fixed by the Synod in accordance with the provisions of the "Registry and Synod Assessment Ordinance 1895" at one-fourth of one per centum per annum in the case of parishes which have not been in existence three years as at the date of the assent to this Ordinance and Parochial and Provisional Districts and by one-half of one per centum per annum in the case of all other parishes.

4. Contributions under Clause 3 of this Ordinance shall be held to be due and payable on the first day of April 1940 and thereafter on the first day of April 1941 and 1942 and shall be paid to the Archbishop to be placed by him to the credit of the Fund created by the "Glebe Administration Further Amendment Ordinance 1937" and shall be together with any unappropriated moneys referred to in the lastmentioned Ordinance administered in like manner as set out in Clause 2 of the said lastmentioned Ordinance.

5. This Ordinance shall remain in force until the thirty-first day of March 1943 except insofar as the administration of the funds then in the hands of the Archbishop.

6. This Ordinance shall be cited as the "Glebe Administration Further Amendment Ordinance 1939."
