

HOLY TRINITY ERSKINEVILLE TRUST FUNDS  
ORDINANCE 1976

No. 7 1976

AN ORDINANCE to vary the trusts on which  
the proceeds from the sale of certain  
land at Newtown shall be held.

WHEREAS Church of England Property Trust Diocese of Sydney (hereinafter  
called "the Corporate Trustee") has pursuant to St. Columb's Newtown  
Sale Ordinance 1975 sold certain land being the land comprised in  
Certificate of Title Volume 1196 Folio 250 and the improvements erected  
5 thereon known as St. Columb's Newtown AND WHEREAS such land was church  
trust property held upon trust to erect or permit to be erected a church  
on the said land and thereafter for church purposes in connection with  
the Church of England AND WHEREAS it is inexpedient to carry out and  
observe the said trusts to the extent to which the same are hereby  
10 varied NOW the Standing Committee of the Synod of the Diocese of Sydney  
HEREBY DECLARES ORDAINS RULES AND DIRECTS as follows:

1. By reason of circumstances which have arisen subsequent to the creation  
of the said trusts it is inexpedient to carry out and observe the same and

\*2. The Corporate Trustee shall apply the proceeds arising from the  
sale of the said land after paying thereout the costs of and incidental  
to this Ordinance as follows:

20 the church and church halls at Holy Trinity Erskineville not  
exceeding \$12,000.00 or such larger sum as may be approved by  
resolution of the Standing Committee

(c) By the investment of the balance of such proceeds together  
with any unexpended portion of the amounts referred to in  
sub-clauses (a) and (b) of this clause. ~~in trust for the said~~

25 ~~part for a period of three years~~

(d) Until the 31st day of May 1979 the Corporate Trustee shall pay

to the churchwardens of Holy Trinity Church Erskineville  
 for general parochial purposes ninety per centum of the income  
 from such investment by quarterly instalments and the balance  
 of such income shall be capitalised.
