

Kingsford (Special Arrangements) Ordinance 2015

No 48, 2015

Long Title

An Ordinance to specify certain administrative arrangements in respect to Holy Trinity, Kingsford.

The Standing Committee of the Synod of the Diocese of Sydney Ordains as follows.

1. Name

This Ordinance is the Kingsford (Special Arrangements) Ordinance 2015.

2. Special Arrangements

(1) The provisions of Schedule 1 of the Parish Administration Ordinance 2008 in relation to Holy Trinity, Kingsford ("Holy Trinity") are modified as follows –

- (a) the annual general meeting of parishioners of Holy Trinity in 2016 (the "2016 AGM") is to be convened and held on a day which is on or after 1 February 2016 and not later than 30 April 2016, or such later date as may be specified by the Archbishop, and
- (b) the following declaration replaces the declaration that must first be subscribed by a person under rule 4.2 of Schedule 1 of the Parish Administration Ordinance 2008 before the person is entitled to take part in or be considered for the purposes of a quorum at the 2016 AGM –

"I am a member of the Anglican Church of Australia.

I have been baptised.

I am not less than 18 years of age.

I have usually during 3 months within the past 12 months attended services of public worship at a church in the parishes of Kingsford, Eastgardens, Maroubra or Malabar or as part of an associated congregation of that church.

I do not claim to be a parishioner of any other church or parish of the Anglican Church of Australia.

I have not voted at a general meeting of parishioners of any church or parish of the Anglican Church of Australia within the past 3 months and, other than Holy Trinity, Kingsford, I do not intend to vote at a general meeting of parishioners of any church or parish of the Anglican Church of Australia within the next 3 months.

Dated this day of 20 ."

- (c) until the 2016 AGM has concluded –
 - (i) a person who is a parishioner of a church of a parish listed in the Schedule is deemed to be a parishioner of Holy Trinity, and
 - (ii) the functions of the wardens of Holy Trinity may be exercised by the person or persons who hold that office at the time the function is exercised, provided that if no person holds that office at the relevant time such functions may be exercised by the minister of the Parish.

(2) The terms "minister" and "parishioner" in this Ordinance have the same meanings as in rule 1.1 of Schedule 1 of the Parish Administration Ordinance 2008.
