

MISCELLANEOUS AMENDMENTS ORDINANCE 1986

No. 26, 1986

AN ORDINANCE to carry out certain law reforms.

WHEREAS it is expedient to clarify and update the terminology of certain ordinances.

5 NOW the Synod of the Diocese of Sydney HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:

St. John's Provisional Cathedral Parramatta Ordinance 1969

1. The St. John's Provisional Cathedral Parramatta Ordinance 1969 is amended —

- 10 (a) by omitting the phrase "Bishop in Parramatta" wherever it appears and by inserting instead "Bishop of Parramatta";
- (b) by omitting from clause 2 the words and figures "Parishes and Provisional Districts Ordinance 1961-1967" and by inserting instead "Parishes Ordinance 1979";
- 15 (c) by omitting from paragraph (b) of sub-clause (5) of clause 10 the words "of Parramatta, The Hawkesbury, The Blue Mountains, Prospect and Liverpool" and by inserting instead "in that part of the Diocese in which the Bishop of Parramatta exercises episcopal duties";
- 20 (d) by omitting from paragraph (b) of sub-clause (5) of clause 10 the words "together with curates-in-charge of provisional districts and resident ministers in new housing districts";
- (e) by omitting from paragraph (c) of sub-clause (5) of clause 10 the words "provisional district" and by inserting instead "new housing district";
- 25 (f) by omitting from paragraph (c) of sub-clause (5) of clause 10 the words "Church of England Constitutions Act Amendment Act of 1902" and by inserting instead "1902 Constitutions";
- 30 (g) by omitting from clause 14 the words "The first elections to take place under the provisions of sub-paragraphs (b) and (c) of paragraph (5) of clause 10 hereof shall be held immediately after assent is given to this Ordinance or at such times and places as the Archbishop shall in writing appoint and the provisions of the Elections Ordinance 1934-1959 (or any amendment thereof) shall apply to such elections.";
- 35 (h) by omitting from clause 18 the words "and functions as such Provisional Cathedral and the financing thereof" and by inserting instead ", functions and financing";
- 40 (i) by omitting from clause 19 all of the words following "Chapter and shall" and by inserting instead "comply with the provisions of the Accounts Ordinance 1975-1978 (as amended from time to time)"; and
- 45 (j) by omitting from clause 24 the figures "-1970".

- (e) by omitting the phrase "Bishop in Wollongong" wherever it appears and by inserting instead "Bishop of Wollongong"; 5
- (b) by omitting from clause 2 the words and figures "Parishes and Provisional Districts Ordinance 1961-1967" and by inserting instead "Parishes Ordinance 1979";
- (c) by omitting from paragraph (b) of sub-clause (5) of clause 10 the words "of Wollongong, Sutherland, Berrima and Campbelltown" and by inserting instead "in that part of the Diocese in which the Bishop of Wollongong exercises episcopal duties"; 10

- (f) by omitting from paragraph (c) of sub-clause (5) of clause 10 the words "Church of England Constitutions Act Amendment Act of 1902" and by inserting instead "1902 Constitutions"; 20
- (g) by omitting from clause 14 the words "The first elections to take place under the provisions of sub-paragraphs (b) and (c) of paragraph (5) of clause 10 hereof shall be held immediately after assent is given to this Ordinance or at such times and places as the Archbishop shall in writing appoint and the provisions of the Elections Ordinance 1934-1959 (or any amendment thereof) shall apply to such elections."; 25 30
- (h) by omitting from clause 18 the words "and functions as such Provisional Cathedral and the financing thereof" and by inserting instead ", functions and financing";
- (i) by omitting from clause 19 all of the words following "Chapter and shall" and by inserting instead "comply with the provisions of the Accounts Ordinance 1975 (as amended from time to time)"; and 35
- (j) by omitting from clause 24 the figures "-1970".

- (a) by omitting from the long title the word "Zone" and by inserting instead "Anglican Regional"; 40

- (d) by omitting from clause 2 the words "Constitutions contained in the Church of England Constitutions Act Amendment Act of 1902" and by inserting instead "1902 Constitutions";
- 10 (e) by omitting from paragraph (d) of clause 2 the words "provisional district";
- (f) by omitting from sub-clause (2) of clause 4 the words "Constitutions contained in the Schedule to the Church of England Constitutions Act Amendment Act of 1902" and by inserting instead "1902 Constitutions"; and
- 15 (g) by omitting from clause 14 the figures "-1983".
