*Moore Theological College Mortgaging Ordinance, 1960.*

No. 14, 1960.

AN ORDINANCE to authorise the further amending of Moore Theological College Mortgaging Ordinance 1952-1959.

WHEREAS:

1. Certain lands particulars whereof are set forth in the Schedules to Moore Theological College Mortgaging Ordinance 1952-1959 (herein called the "Principal Ordinance") are held in trust for the use and benefit and purposes of Moore Theological College.

2. It is expedient by reason of circumstances subsequent to the creation of the trusts to which the lands mentioned in the Principal Ordinance are subject to amend the Principal Ordinance by enlarging the amount which may be borrowed.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:—

1. (1) This Ordinance may be cited as Moore Theological College Mortgaging Ordinance, 1960.

(2) The Principal Ordinance as amended by this Ordinance may be cited as Moore Theological College Mortgaging Ordinance 1952-1960.

2. By reason of circumstances subsequent to the creation of the trusts to which the lands mentioned in the Principal Ordinance and Amending Ordinance are subject it is expedient to amend the Principal Ordinance as follows:—

1. By deleting from line 3 of Clause 2 the words "not exceeding Twenty thousand pounds".

2. By inserting in the Schedule of the Moore Theological College Ordinance 1959 as parcel 10 thereof the following land:—

All those pieces or parcels of land situate at Newtown in the Parish of Petersham County of Cumberland City of Sydney, and being Lots 3, 7, 8, 9, 10, 11, 12, 13, 14, 16, 18, 19, 20, 21 and 23 as shown on litho plan Number 32916 and being the whole of the land comprised in Certificate of Title Volume 7575 Folio 220 together with all improvements erected thereon and known as

Numbers 16, 8, 6, 4 and 2 Little Queen Street and Numbers 33, 35, 37, 39, 43 and 47 King Street and Numbers 107, 109, 111 and 115 Campbell Street, Newtown.
