
Mowll Memorial Village Management Ordinance 1962

No. 21, 1962.

AN ORDINANCE to provide for the management and control of Mowll Memorial Village by the Board of the Sydney Church of England Homes for Aged Persons, and to amend the Sydney Church of England Homes for Aged Persons Constitution Ordinance 1961.

WHEREAS the Mowll Memorial Village is and has been since its establishment under the management and control of the Board of Management of Church of England National Emergency Fund Diocese of Sydney (hereinafter referred to as C.E.N.E.F.) AND WHEREAS by the Sydney Church of England Homes for Aged Persons Constitution Ordinance 1961 a Board of Management was constituted and appointed to control and manage the organisation known as "Sydney Church of England Homes for Aged Persons" AND WHEREAS it is expedient that the control and management of the Mowll Memorial Village be henceforth managed administered and controlled by such Board of Management in lieu of the Board of Management of C.E.N.E.F. as heretofore AND WHEREAS in order to enable the said Board of Management to assume and undertake such position and powers it is necessary to amend the said recited Ordinance NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod HEREBY ORDAINS DIRECTS AND RULES as follows:-

1. Clause 5 of the Sydney Church of England Homes for Aged Persons Constitution Ordinance 1961 is hereby amended as follows:-

By inserting the figure (i) in front of the words "To Manage" and by inserting the following sub-clause:

(ii) To manage administer and control the property both real and personal of any other organisation or home providing accommodation for persons of pensionable age the control of which may from time to time by Ordinance be committed to the Board.

2. The property known as The Mowll Memorial Village and the management and user thereof shall henceforth be under the control and administration of the Board of the Sydney Church of England Homes for Aged Persons in lieu of the Board of Management of C.E.N.E.F. as heretofore.

3. Nothing in this Ordinance shall be construed as affecting or varying the trusts upon which the property of the Mowll Memorial Village is now held.

4. This Ordinance may be cited as "Mowll Memorial Village Management Ordinance 1962."
