Provincial Synod Constitution (Amendment) **Ordinance** 1970 Adopting Ordinance 1970

An Ordinance for adopting a certain Ordinance of the Provincial Synod of N.S.W. entitled "Provincial Synod Constitution (Amendment) Ordinance 1970".

WHEREAS a certain Ordinance entitled "Provincial Synod Con-WHERMAS a certain Ordinance entitied "Provincial Synod Constitution (Amendment) Ordinance 1970" a copy of which is contained in the Schedule hereto was passed by the Synod of the Province of New South Wales on the 15th day of April, 1970 AND WHEREAS it is expedient that the said Ordinance should be adopted by the Church in this Diocese NOW the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of England in Ametrilia within the government of the Church of England in Australia within the State of New South Wales HEREBY ORDAINS DECLARES DIRECTS AND RULES as follows:-

The said Ordinance contained in the Schedule hereto is hereby adopted and so far as the same is applicable shall be applied to the management and good government of the Church in this Diocese.

This Ordinance may be cited as "Provincial Synod Constitution (Amendment) Ordinance 1970 Adopting Ordinance 1970".

SCHEDULE

THE PROVINCIAL SYNOD CONSTITUTION (AMENDMENT) ORDINANCE 1970

The Provincial Synod of the Province of New South Wales ORDAINS PRESCRIBES AND RULES as follows:

- (1) This Ordinance may be cited as the "Provincial Synod Constitution (Amendment) Ordinance 1970".
 - (2) The Provincial Synod Constitution Ordinance of 1907 as amended by the Provincial Synod Constitution Ordinance of 1957 is in this Ordinance referred to as the "Principal Ordinance"
 - (3) The Principal Ordinance as amended by this Ordinance may be cited as the "Provincial Synod Constitution Ordinance 1907-1970".
- The Constitution of the Provincial Synod of the Province of New South Wales contained in the Schedule to the Principal Ordinance is amended -
 - (a) By omitting from Clause 12 the words "Every Ordinance of the Provincial Synod shall be made by a majority of each House".
 - (b) By omitting Clause 15.(c) By omitting Clause 17.
