AN ORDINANCE for accepting and adopting Articles and Provisions to alter Clause three of the Constitution of the Provincial Synod of New South Wales which deals with the number of Representatives from Dioceses to that Synod passed by the Provincial Synod of the Province of New South Wales on the seventeenth day of August one thousand nine hundred and seventeen intituled "Articles and Provisions to alter Clause three of the Constitution which deals with the number of Representatives from Dioceses to this Synod."

WHEREAS certain Articles and Provisions were passed by the Provincial Synod of the Province of New South Wales on the seventeenth day of August one thousand nine hundred and seventeen intituled "Articles and Provisions to alter Clause three of the Constitution which deals with the number of Representatives from Dioceses to this Synod" a copy of which is contained in the Schedule annexed to this Ordinance. AND WHEREAS it is expedient that the said Articles and Provisions shall be accepted and adopted by the Church in this Diocese. The Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Constitutions for the management and good government of the Church of Eugland within the State of New South Wales ordains and rules:—

1. That the said Articles and Provisions and each and every of them shall be and the same are and is hereby accepted and adopted and shall so far as the same are applicable be applied to the management and government of the Church in this Diocese in like manner as if the said Articles and Provisions and each and every of them had been ordained and ruled by the Synod of this Diocese.

SCHEDULE.

ARTICLES AND PROVISIONS to alter Clause three of the Constitution which deals with the number of Representatives from Dioceses to this Synod.

WHEREAS "The Provincial Synod Constitution Ordinance of 1907" provides that the Provincial Synod may from time to time pass Articles and Provisions altering the said Constitution saving Clauses 9 and 10 thereof AND WHEREAS it is expedient to pass Articles and Provisions altering Clause 3 of the said Constitution which deals with the number of Representatives from Dioceses to the said Synod. Now therefore the Provincial Synod of New South Wales ordains and rules as follows:—

- 1. Each Diocese having under 31 Clergymen duly licensed to officiate within it shall be entitled to send to any future Synod four Clerical and four Lay Representatives.
- 2. And each Diocese having above 30 and under 51 such Clergymen shall be entitled to send six Representatives of each order as aforesaid.
- 3. And each Diocese having above 50 and under 71 such Clergymen shall be entitled to send eight Representatives of each order as aforesaid.
- 4. And each Diocese having above 70 and under 96 such Glergymen shall be entitled to send ten Representatives of each order as aforesaid.
- 5. And each Diocese having above 95 and under 121 such Clergymen shall be entitled to send twelve Representatives of each order as aforesaid.
- And each Diocese having above 120 and under 146 such Clergymen shall be entitled to send fourteen Representatives of each order as aforesaid.
- 7. And each Diocese having above 145 and under 176 such Clergymen shall be entitled to send sixteen Representatives of each order as aforesaid.

Provincial Synod Representatives.

- 8. And each Diocese having above 175 and under 206 such Clergymen shall be entitled to send eighteen Representatives of each order as aforesaid.
- 9. And each Diocese having above 205 and under 236 such Clergymen shall be entitled to send *twenty* Representatives of each order as aforesaid.
- 10. And each Diocese having above 235 and under 266 such Clergymen shall be entitled to send twenty-two Representatives of each order as aforesaid.
- 11. And each Diocese having above 265 such Clergymen shall be entitled to send twenty-four Representatives of each order as aforesaid.

We certify that the foregoing articles and provisions were passed by the Provincial Synod of the Province of New South Wales this seventeenth day of August, 1917.
