

*Saint Philip's Sydney (Rectorship) and Moore
Theological College (Principalship) Ordinance 1935.*

No. 15, 1935.

AN ORDINANCE to provide for the appointment of a person who shall hold at the same time the offices of Rector of the Parish of St. Philip Sydney and Principal of Moore Theological College Sydney and to provide for the simultaneous determination of the tenure of the said offices and for other purposes incidental thereto.

The Synod of the Diocese of Sydney ordains directs declares and rules as follows:—

1. The "St. Philip's Rectorship Ordinance of 1924" is hereby repealed.

2. Clause 2 of "The Moore Theological College Ordinance of 1919" is amended by the omission of the following words:— "to appoint the Principal after consultation with the Committee and".

3. The Parish of St. Philip Sydney is hereby excluded from the provisions of clauses 14 to 21 inclusive of the Presentation and Exchange Ordinance of 1933 or any provisions amending or taking the place of the same.

4. Vacancies in the offices of the incumbent of the Parish of St. Philip Sydney and Principal of Moore Theological College may from time to time be filled as follows viz.:—

The Archbishop with the approval of the Trustees or a majority of the Trustees of the Will of Thomas Moore shall nominate a person or persons to a joint meeting of the Standing Committee of Synod and the Parish Representatives of the parish of St. Philip Sydney and such of the said persons whose name shall receive a majority of the votes of the said Standing Committee and Parish Representatives taken collectively may be appointed by the Archbishop to the said offices.

5. Notwithstanding any other provisions no appointment shall be made by the Archbishop unless the person so chosen agrees in writing beforehand and the Archbishop specifies the same in the document of appointment to be issued by him that the said appointment may be terminated in the manner hereinafter appearing.

6. The said appointment may be terminated from time to time as follows viz.:—

The Archbishop with the approval of the Trustees or a majority of the Trustees of the Will of Thomas Moore shall report to a joint meeting of the Standing Committee of Synod and the Parish Representative of the parish of St. Philip Sydney that in his opinion the appointment should be terminated and upon a majority of votes of the said Standing Committee and Parish Representatives taken collectively endorsing the opinion of the Archbishop the said appointment shall be terminated.

7. The person appointed to the said offices shall reside at Moore Theological College and shall preach on Sundays not less than thirty times in the year in the Church of St. Philip Sydney.

A responsible member of the staff of Moore Theological College being a duly ordained Clergyman in Priest's Orders shall reside in the Rectory of the Church of St. Philip Sydney and shall under the direction of the Rector have the pastoral oversight of the parish.

INTERPRETATION.

8. In this Ordinance unless inconsistent with the context "Archbishop" and "Parish Representative" shall have the same meanings respectively as prescribed in "The Presentation and Exchange Ordinance 1933."

9. This Ordinance may be cited as "Saint Philip's Sydney (Rectorship) and Moore Theological College (Principalship) Ordinance 1935 "
