
*St. Barnabas Sydney Mortgaging Ordinance 1944.
Amendment Ordinance 1949.*

No. 11, 1949.

AN ORDINANCE to amend the St. Barnabas Sydney Mortgaging Ordinance 1944, to provide for the borrowing on mortgage of a further sum and the application of the proceeds thereof.

WHEREAS by the St. Barnabas Sydney Mortgaging Ordinance 1944 (hereinafter called the Principal Ordinance) the Church of England Property Trust Diocese of Sydney (therein and hereinafter called the Corporate Trustees) was authorised and empowered to mortgage the land comprised in the Schedule to the said principal Ordinance for the purpose of borrowing when the power was first exercised the sum of Eight hundred pounds (£800) and to apply the moneys so received as therein set out. AND WHEREAS in pursuance of such power the sum of Eight hundred pounds (£800) was so borrowed and applied by the Corporate Trustees. AND WHEREAS it has become necessary to effect certain further repairs and renovations to the Rectory used in connection with the Church of St. Barnabas Sydney and also certain repairs and renovations to the said Church and for such purpose it is expedient to borrow upon the security of the same or another mortgage over the said land an additional sum of Seven hundred (£700). Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:—

1. This Ordinance may be cited as the "St. Barnabas Sydney Mortgaging Ordinance 1944 Amendment Ordinance 1949."

2. (a) The "St. Barnabas Sydney Mortgaging Ordinance 1944" is in this Ordinance referred to as the Principal Ordinance.

(b) The Principal Ordinance, as amended by this Ordinance may be cited as the "St. Barnabas Sydney Mortgaging Ordinance 1944-1949."

3. By reason of circumstances subsequent to the Trusts recited in the Principal Ordinance it is expedient to amend the same as hereinafter appears:—

4. Clause 1 (i) (a) of the Principal Ordinance is amended by deleting the figures Eight hundred pounds (£800) and inserting in their place the figures One thousand five hundred pounds (£1,500).

5. Clause 2 (b) is amended by inserting the words "and Church" after the words "Rectory" where therein appearing.
