
*St. Catherine's Clergy Daughters' School (Change of Name
and Council Incorporation) Ordinance 1955.*

No. 22, 1955

AN ORDINANCE to alter the name of St. Catherine's Clergy Daughters' School; and to authorise the incorporation of the Council of the said School as a body corporate pursuant to the provisions of the Church of England (Bodies Corporate) Act, 1938.

WHEREAS by the St. Catherine's Clergy Daughters' School Ordinance 1922 the Synod of the Diocese of Sydney inter alia named the Institution referred to in the Preamble thereto as the "St. Catherine's Clergy Daughters' School" and constituted a Council of the said School and provided for the management of its affairs AND WHEREAS it is expedient to alter the name of the said School to St. Catherine's School Waverley AND WHEREAS the said Ordinance was amended in certain particulars by the Casual Vacancies Ordinance 1935.

AND WHEREAS the Church of England (Bodies Corporate) Act 1938 was assented to on the twenty-sixth day of October, 1938.

AND WHEREAS it is expedient that the Council of the said School should be constituted a body corporate as provided for in the said Act.

Now the Synod of the Diocese of Sydney ordains directs and rules as follows:—

1. (1) As from the commencement of this Ordinance:—
 - (a) the name of the School heretofore known as St. Catherine's Clergy Daughters' School shall be St. Catherine's School, Waverley;
 - (b) the Council heretofore known as The Council of St. Catherine's Clergy Daughters' School shall be known as The Council of St. Catherine's School, Waverley;
 - (c) a reference in any Ordinance or other instrument or document whatsoever to St. Catherine's Clergy Daughters' School and The Council of St. Catherine's Clergy Daughters' School shall be read and construed as a reference to the St. Catherine's School Waverley and The Council of St. Catherine's School Waverley respectively.

(2) The alterations effected by sub-clause one of this clause:—

(a) shall not prejudice or affect the continuity of the Council constituted under the St. Catherine's Clergy Daughters' School Ordinance 1922;

(b) shall not affect any property, powers, rights, authorities, duties, functions, liabilities or obligations of the said Council or render defective any legal or other proceedings instituted or to be instituted by or against the said Council.

2. The Synod hereby declares that it is expedient for the purpose of managing governing or controlling St. Catherine's School Waverley an institution or organisation of the Church of England that the persons who for the time being are members of the unincorporated body of the Council of St. Catherine's School Waverley should be constituted a body corporate under the name of "The Council of St. Catherine's School Waverley."

3. This Ordinance may be cited as the "St. Catherine's Clergy Daughters' School (Change of Name and Council Incorporation) Ordinance 1955."
