*St. George's Earlwood Mortgaging Ordinance  
(Amendment) Ordinance 1954.*

AN ORDINANCE to amend the "St. George's Earlwood Mortgaging Ordinance 1953" to provide for the borrowing on mortgage of a further sum and the application of the proceeds thereof.

WHEREAS by the "St. George's Earlwood Mortgaging Ordinance 1953" (hereinafter called the Principal Ordinance) the Church of England Property Trust Diocese of Sydney (therein and hereinafter called the Corporate Trustee) was authorised and empowered to mortgage the land comprised in the Schedule to the principal ordinance for the purpose of borrowing when the power was first exercised the sum of Eleven thousand pounds (£11,000) for the purpose of erecting a new Church on the said land AND WHEREAS by reason of circumstances which have arisen since the passing of the principal Ordinance it has become necessary to increase the amount so authorised to the sum of Sixteen thousand pounds (£16,000) in order to complete the said Church Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:—

1. This Ordinance may be cited as "St. George's Earlwood Mortgaging Ordinance (Amendment) Ordinance 1954."

2. (a) The "St. George's Earlwood Mortgaging Ordinance 1953" is in this Ordinance referred to as the Principal Ordinance.

(b) The Principal Ordinance as amended by this Ordinance may be cited as the "St. George's Earlwood Mortgaging Ordinance 1953-1954."

3. By reason of circumstances subsequent to the trusts recited in the Principal Ordinance it is expedient to amend the same as hereinafter appears.

4. (i) Clause 1, Sub-Clauses (a) and (b) of the Principal Ordinance are amended by deleting the words and figures "Eleven thousand" "(£11,000)" and inserting in their place the words and figures "Sixteen thousand" "(£16,000)" in each Sub-Clause.
- (ii) Clause 1 (b) of the Principal Ordinance is amended further by deleting the words and figures "Three hundred" "(£300)" and inserting in their place the words and figures "Six hundred" "(£600)."
