
*St. Luke's Berry (Foxground Insurance Money) Variation of
Trust Ordinance 1958.*

No. 6, 1958.

AN ORDINANCE to vary the trusts upon which certain funds are held for the Church of St. James' Foxground and to provide for the application of such funds.

WHEREAS in or about the month of October One thousand nine hundred and fifty four the Church of St. James Foxground was destroyed by fire and the sum of One thousand pounds (£1000) was paid in respect of the fire insurance on the said church AND WHEREAS at the time of the said fire the said church was situated in the Parish of Kiama but was previously and is now situated in the Parish of St. Luke Berry AND WHEREAS the said insurance money was subsequently and is still invested in Debenture No. 1605 issued by the Metropolitan Water Sewerage and Drainage Board at $4\frac{1}{2}\%$ maturing on 1st June 1965 (hereinafter called the said Fund) and is held by the Commonwealth Trading Bank of Australia Kiama Branch on behalf of Austin Alfred Hall, George Thomas Cullen and Frank William Slater (hereinafter called the Trustees of the said Fund) for the benefit of the Church of England at Foxground AND WHEREAS it is inexpedient to rebuild the Church of St. James at Foxground or to apply the said Fund in and towards such purpose and it is expedient that the said Fund be applied in and towards the erection of a church hall at Gerringong in the Parish of St. Luke Berry aforesaid.

Now the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod Ordains and Directs as follows:—

1. By reason of circumstances which have arisen subsequent to the creation of the trusts upon which the said Fund is held it is inexpedient to carry out and observe the same and it is expedient to vary the said trusts as hereinafter set out.

2. The said Fund shall henceforth be held by the Trustees of the said Fund upon trust to apply the same and all income accrued and henceforth to accrue thereon in and towards the erection of a church hall at Gerringong in the Parish of St. Luke Berry as and when the Churchwardens of St. George's Gerringong shall require.

3. This Ordinance may be cited as "St. Luke's Berry (Foxground Insurance Money) Variation of Trust Ordinance 1958."
