*"St. Mary's Church Mortlake Sale and Mortgage Amending Ordinance 1941."*

No. 1, 1941.

AN ORDINANCE to amend an Ordinance to authorise the sale and mortgage of certain lands situated at Mortlake near Sydney and more particularly described in the Schedules thereto and to provide for the application of the proceeds thereof and for other purposes incidental thereto.

WHEREAS it is expedient to amend "St. Mary's Church Mortlake Sale and Mortgage Ordinance 1938" by alteration of the amount and the application of the proceeds of the mortgage thereby authorised and otherwise as herein provided.

NOW the Standing Committee of the Synod of the Diocese of Sydney in the name and place of the said Synod ordains and declares as follows:

1. Section 4 of the "St. Mary's Church Mortlake Sale and Mortgage Ordinance 1938" is hereby amended by adding at the end thereof the words following that is to say:—

"either before the making of any mortgage hereinafter authorised or thereafter subject thereto."

2. Section 8 of the said Ordinance is hereby amended by omitting the words "second Schedule" and inserting in their place the words "1st, 2nd and 3rd Schedules hereto."

3. Section 9 (1) of the said Ordinance is hereby amended by omitting the words "said land" and inserting in their place the words "lands described in the 1st, 2nd and 3rd Schedules hereto."

4. Section 9 (1) (a) is hereby amended by omitting the figures "£800" and inserting in their place the figures "£1600."

5. Section 9 (1) (b) is hereby amended by omitting the figures "£30" and inserting in their place the figures "£15."

6. Section 10 is hereby amended by inserting immediately after the words "this Ordinance" the words and figures following, that is to say:—

"The amount of the existing loan for the Parish Hall Building amounting to £320 or thereabouts the amount of the existing loan for the purchase of the Parish Hall land plus the accumulated interest and expenses amounting to £200 or thereabouts."

7. Upon the payment of the said amount of the existing loan for the purchase of the Parish Hall land plus the accumulated interest and expenses as above mentioned the land described in the 3rd Schedule hereto shall be held upon trust to permit the same to be used for a Church Parsonage or Parish Hall or partly for one and partly for another or others of such purposes in connection with the Church of England in the Provisional District of Mortlake being the District for which the said purchase was made.

8. This Ordinance shall be read as amending and supplementing "St. Mary's Church Mortlake Sale and Mortgage Ordinance 1938" and shall be styled and cited as "St. Mary's Church Mortlake Sale and Mortgage Amending Ordinance 1941."
