*Trinity Grammar School Sale and Mortgage Amendment  
Ordinance 1940.*

AN ORDINANCE to amend Clauses 3 of "Trinity Grammar School Sale and Mortgage Ordinance 1928."

WHEREAS by the "Trinity Grammar School Sale and Mortgage Ordinance 1928" the Church of England Property Trust Diocese of Sydney (therein called the Trust) was directed and authorised to sell such part of the lands described in the first schedule as it may deem expedient and to mortgage at any time and from time to time the whole or any part or parts of the lands described in the first and second schedules thereto to secure an advance or advances of money not exceeding thirty-five thousand pounds in all and to apply the proceeds obtained on the security of any such mortgage or mortgages for the purposes therein set out AND WHEREAS in pursuance of the said authority to sell the said Trust has sold portion of the lands described in the said first schedule and in pursuance of the said authority to mortgage has mortgaged the said lands described in the first and second schedule thereto but the advance or advances secured by such mortgage or mortgages is or are less than the said sum of thirty-five thousand pounds AND WHEREAS by the "Trinity Grammar School Constitution Ordinance 1928" it was provided that Trinity Grammar School shall be governed by a Council appointed in the manner hereinafter mentioned and that the said Council shall manage and carry on the said School and its affairs and shall govern and control the management and user of the Church trust property at any time held in connection therewith in such manner as it may deem expedient for the benefit of the said School AND WHEREAS it is proposed to further mortgage the portion of the said land described in the said first schedule thereto and remaining unsold and the lands described in the said second schedule thereto AND WHEREAS it is expedient to declare further purposes for and to which the proceeds of any such mortgage or mortgages may be applied as hereinafter provided NOW THEREFORE the Standing Committee of the Synod of the Diocese of Sydney in pursuance of the powers in that behalf conferred upon it by the Church of England Trust Property Act 1917 and the Land Ordinance Procedure and Delegation of Powers Ordinance 1926 and in pursuance of the powers vested in the said Synod by the Consti-

tutions for the management and good government of the Church of England within the State of New South Wales or otherwise in the name and in the place of the said Synod directs declares and rules as follows:—

1. The said Ordinance is hereby amended by inserting in Clause 3 thereof immediately after the word "fit" the following words: "including the cost of repair renovation construction or reconstruction of any building or buildings or other improvements used or to be used in connection with the said School upon the said lands or any part thereof and the discharge of debts now or hereafter incurred by the said Council in the management and carrying on of the said School."

2. This Ordinance may be cited as "Trinity Grammar School Sale and Mortgage Amendment Ordinance 1940."
